To assist in facilitating our communication goals and awareness building strategies, the Commission was fortunate to be able to bring on a contract Social Media Coordinator beginning in April 2022. Angelena Castro is serving this role. Her responsibilities include executing a social media strategy for the AAHC Instagram account, creating the editorial calendar for AAHC social media platforms, and creating numerous social media campaigns. Ms. Castro worked previously as a DNCR Marketing Team contractor where she collaborated with the Commission on the initial Green Book Project social media campaigns. She is a graduate of NC Agricultural and Technical State University, and in 2018 she served as an intern in the NCDNCR HBCU/MIHE Internship Program.

NCAAHC STRATEGIC PLAN & ANNUAL GOALS, FY 2022-2023

Per the NCAAHC Strategic Plan, this fiscal year the Associate Director will begin planning convenings for grassroots groups around statewide African American heritage needs and professional development opportunities. Two potential groups have been identified for meeting in 2024: local and regional African American heritage commissions, and those who steward historic Rosenwald school buildings. Additionally, the NCAAHC's ongoing Institute of Museum and Library Services Grant for "A Tale of Two Ships: Part Deux", planning will begin for an international scholar convening.

TRAIL UPDATES

African American Music Trails of Eastern North Carolina

The NC Legislature declared 2023 as the North Carolina Year of the Trail as an opportunity to showcase, promote and celebrate our state's extensive trail systems, including its cultural trails. In recognition of this, the NCAAHC has prioritized cultural trail work for fiscal year '22-'23. Additionally, the African American Music Trails of Eastern North Carolina, which were developed in partnership with the NCAAHC and the N.C. Arts Council, have come under the stewardship of the NCAAHC. Currently, the NCAAHC is planning for trail reactivation. This will include booking and installing trail-related traveling exhibits in early 2023, developing digital content, and engaging the community around the future of the trail.

Oasis Spaces: North Carolina Green Book Project

As a continuation of our work on the North Carolina Green Book Project, under the mentorship of NCAAHC Associate Director the Commission was excited to welcome a DNCR HBCU/MIHE Intern this summer, Rosalind Kinlow. Rosalind is currently enrolled at NC Central University in their History Master's Degree Program. She working to research and craft additional essays on Green Book sites for our online web portal. Additionally, she has participated in several professional development opportunities including work groups for the Commission's African American Cultural Heritage Action Fund Grant, as well as connecting with professionals across the Commission's network.

Freedom Roads

In close collaboration with the NCAAHC Trails Coordinator, Ashley Adams, the NCAAHC Associate Director has led work to activate the trail through waysides. This has included the development of several new physical resources for Freedom Roads, including rack cards to be placed at a series of historic sites. Ashley's work has included developing historical tabletop waysides chronicling freedom seeking stories at the following sites:

- Stagville State Historic Site
- Brunswick Town/Ft. Anderson State Historic Site
- Somerset Place State Historic Site
- Great Dismal Swamp State Park
- Elizabeth City State University

PROJECT UPDATES

Black History Month & Juneteenth

Fiscal year '21-'22 saw the continued formalization of NCAAHC's celebration of Black History Month and Juneteenth on a department and state-wide level. NCAAHC has continued to serve as a consistent resource to those interested in celebrating. This included the creation of a landing page for each celebration including resources and materials encouraging thoughtful celebration. Both a Black History Month and Juneteenth Toolkit were created, the latter of which had two versions to support external and internal DNCR celebrations.

For the first time, resources also included a Juneteenth Speaker's Bureau and sponsorships to support celebrations across the state, very much prioritizing grassroots support and maximizing the power of outreach rather than an individual program.

Staffing

To facilitate the dispersant and assemblage of resources, the Commission was fortunate to be able to bring on a fulltime temporary Program Coordinator via TempSolutions beginning in January 2022. Okirah Harris is serving this role. Her responsibilities included designing and creating resource materials, facilitating the Juneteenth Speaker's Bureau, and collaborating with the DNCR marketing team. Ms. Harris worked previously in Roy Cooper's Office of Public Engagement where she collaborated with the Commission on Black History Month celebrations. She recently graduated with a Master of Arts from the UNC Hussman School of Journalism and Media.
