## MINUTES BOARD OF EDUCATION, RALEIGH CITY ADMINISTRATIVE UNIT ADMINISTRATION BUILDING September 6, 1960

September 6, 1960 12:30 P.M.

The Board of Education of the Raleigh City Administrative Unit held a meeting in the Administration Building on Tuesday, September 6, 1960, at twelve thirty o'clock with the following members present: Chairman W.G. Enloe, Mrs. J. L. Stough, Mr. J. W. York, Mr. Lewis H. Powell, Mr. V.E. Fisher and Mr. LeRoy Martin.

Upon motion by Mrs. Stough, seconded by Mr. Powell, the minutes of the meeting on August 2 were unanimously approved.

A motion by Mr. Fisher, seconded by Mr. Martin that the following new teachers recommended by the superintendent be elected for 1960-1961 was unanimously passed:

Kate O'S. Ledford, Nancy B. Moore, Clara D. Avery, Gloria W. Butler, Josephine R. Johnson, Henry C. Jones, Bernestine Walker Sanders

Upon motion by Mr. Fisher, seconded by Mr. Martin, Estelle D. Gipson and Eunice G. Jones, who were recommended by the superintendent, were elected as replacement teachers.

The secretary read a letter from Mr. Earl Jones, President of Raleigh Baseball, Inc., requesting that the board consider reducing the rental on Devereux Meadow from \$1,000.00 to \$500.00 for 1961. After a discussion of this request, Mr. Martin moved that the rental be reduced to \$750.00 for 1961. The motion was seconded by Mr. Powell and unanimously passed.

A letter from Wm. C. Lassiter, attorney for the board in the Ammons condemnation case suggesting that the board consider increasing the witness fees paid to Messers. R. F. Harris, L. M. Shirley, and E. G. Cothran \$75.00 each was read to the board. The court allowed witness fees for these three witnesses in the sum of \$25.00 each. All three witnesses were in court two days. Upon motion by Mr. York, seconded by Mr. Powell, the board unanimously approved payment of an additional witness fee of \$75.00 each to L. M. Shirley, R. F. Harris and E. G. Cothran.

The superintendent reported that Ralph Campbell and wife, 804 E. Edenton Street, had requested that their son William, second grade, be assigned to Murphey School and that their daughter Mildred Vivian, eighth grade and son Ralph, ninth grade be assigned to Hugh Morson Junior High School. The superintendent stated that he had tentatively assigned William

to Thompson School and Mildred Vivian and Ralph to J. W. Ligon High School since these children would normally attend these schools. Mr. York moved that in the interest of the students and in the best interest of the Raleigh Schools, William be assigned to Murphey School and Mildred Vivian and Ralph be assigned to J. W. Ligon Junior-Senior High School. The motion was seconded by Mr. Martin and unanimously passed.

Upon motion of Mr. Fisher, seconded by Mr. York, the board approved an increase of \$2,000.00 in the superintendent's travel allowance for the purpose of defraying expenses for a study tour of Russia.

The superintendent submitted the following applications for assignments and for change of assignment:

L. Stough, Mr. F. J. Carnage, Mr. Vic Fisher, Mr. Lewis H. Powell.

Upon motion by Mr. Powell, seconded by Mr. Fisher, the minutes of the meeting on September 6 were unanimously approved.

A motion by Mrs. Stough, seconded by Mr. Carnage, that Mrs. Grace B. Cox, who was recommended by the superintendent, be elected as a teacher of a class of trainable mentally retarded children was unanimously passed.

The motion was seconded by Mrs. Stough and unanimously passed.

The secretary read the following letter from Ralph Campbell:

"To Members of the Raleigh Board of Education:

"I wish to appeal your decision assigning my son, Ralph Campbell Jr. and my daughter, Mildred Vivian Campbell, to the J. W. Ligion Junior Senior High School subsequent to my former request that they be assigned initially to the Hugh Morson Junior High School.

"I request the hearing, provided by law, before the Raleigh Board of Education to establish whatever findings of cause and fact which may be necessary for your reconsideration of the assignment which is unsatisfactory to me.

"Please inform me of the time and place when I may appear before the Board and of any other requirements I should meet in furthering my appeal.

The chairman called on Mr. Campbell for any statement he wished to make regarding the assignment of his son Ralph Campbell, Jr. and his daughter Mildred Vivian Campbell. Mr. Campbell stated that he was dissatisfied with the assignment of his children and that his children were also dissatisfied with their assignments.

The application for change of assignment of Ralph Campbell, Jr. and Mildred Vivian Campbell was in letter form and not on the form provided

by the board. Mr. Carnage moved that the superintendent be requested to forward to the applicant the approved forms and upon receipt of the completed forms bring the matter to the attention of the board for action. The motion was seconded by Mr. Fisher and unanimously passed.

The secretary called the board's attention to the State Highway Commission's plan to move the roadway on the eastern side of Aldert Root School one hundred or more feet on the Aldert Root School site. After considerable discussion, Mr. Fisher moved that the superintendent be authorized to notify the State Highway Commission that the board disapproved the plans to move the roadway westward on Aldert Root School grounds because of the serious damage to school property and that this problem be re-referred to the Building and Sites Committee. The motion was seconded by Mr. Powell and unanimously passed.

The superintendent recommended that the following Minimum Requirements for Graduation become effective with the class of 1964:

Upon motion of Mrs. Stough seconded by Mr. Carnage the board unanimously approved that above Minimum Requirements for Graduation as recommended by the superintendent, effective with the class of 1964.

A motion by Mr. Fisher, seconded by Mr. Powell, that schools be closed at 12:30 P.M. on October 11 for the purpose of permitting students to attend the North Carolina State Fair was unanimously passed.

Upon motion by Mr. Fisher seconded by Mrs. Stough, the superintendent was authorized to pay the local salary supplement in two installments, the first payment on the fourth month payroll date and the second installment on the ninth month payroll date.

The superintendent submitted the following applications for assignments and for change of assignment:
