# **Traveling Exhibits**

We currently have 2 traveling exhibits that are out on the road; our Green Book Traveling exhibit and our African American Music Traveling exhibit

Our Green Book Exhibit highlights the "The Negro Motorist Green Book" published from 1933-1966 that was used as a travel guide for African Americans moving throughout the South. This guide provided safe spaces for African American travelers to eat, lodge and find entertainment. The exhibit highlights over 300 Green Book sites right here in North Carolina that hosted a number of people throughout the Jim Crow Era.

Developed by the NC Arts Council in 2019, the African American Musicians traveling exhibit highlights the contributions that Eastern North Carolina has made to the musical genres of jazz, blues, funk, soul, gospel and hip-hop throughout North Carolina. This exhibit comes with an interactive touch-screen kiosk.

Lastly, we at the Commission have the Africa to Carolina traveling exhibit that documents the disembarkation of enslaved Africans that arrived at North Carolina's ports of Bath, Beaufort, Brunswick, Edenton, New Bern and Wilmington.

I've created a system to streamline exhibits including submission of Loan Agreements and reviewing terms prior to booking. I am in the process of creating an online booking system for all exhibits. It will allow for constituents to request which exhibit they'd like, the date they'd each exhibit is considered first-come, first-served. This system along with keeping a spreadsheet of exhibit site hosts aids in making sure that we are not overlapping and that each site that would like the exhibit will have it at least once within the calendar year.
